

# Whitespace New Stamps Quick Reference Guide

## **Lloyd's Syndicate:**

'Code' – Lloyd's of London 4-digit registration number

'Pseudonym' – Lloyd's of London 3-letter assigned pseudonym

'Stamp Description' – the text "Lloyd's Underwriter Syndicate Number" then the code and pseudonym

'Short Description' – text precisely identifying the stamp in the Stamps panel list

## **Lloyd's Brussels Syndicate:**

'Code' – Lloyd's Brussels 4-digit registration number starting with 5

'Pseudonym' – Lloyd's Brussels 3-letter assigned pseudonym

'Stamp Description' – the Brussels syndicate name, code, and pseudonym, then the text "reinsured by", then the Lloyd's of London code and pseudonym of the reinsuring syndicate

'Short Description' – text precisely identifying the stamp in the Stamps panel list.

## **Lloyd's Consortium:**

'Code' – Lloyd's of London 4-digit registration number starting with 4, 7, or 9

'Pseudonym' – Lloyd's of London 3-letter assigned pseudonym

'Stamp Description' – the consortium's full name then the text "All underwriters registered as per LPSO" and then the code.

'Short Description' – text precisely identifying the stamp in the Stamps panel list

## **Lloyd's Brussels Consortium:**

'Code' – Lloyd's of London 4-digit registration number starting with 4, 7, or 9

'Pseudonym' – Lloyd's of London 3-letter assigned pseudonym

'Stamp Description' – the Lloyd's Brussels consortium's full name, the code, and the text "All underwriters registered as per LPSO" and then the LPSO registration number of the associated non-Europe consortium, the text "reinsured by" and the full name and Lloyd's of London code of the reinsuring consortium; note that it is **critical** that the registration numbers of the Lloyd's Brussels, LPSO, and Lloyd's Reinsurance consortiums all be present and clearly differentiated

'Short Description' – text precisely identifying the stamp in the Stamps panel list

## **MGA:**

'Code' – the UMR (up to 17 digits beginning with B) of the Binding Authority Agreement; the Binders agreement number; or any other appropriate agreement number or code for the capacity behind the MGA, such as a DUNS code

'Stamp Description' – full details of the binding authority agreement, the full details of the delegation, and the phrase "Premiums and claims are to be settled via Bureau" and, optionally, LPSO registration details

'Short Description' – text precisely identifying the stamp in the Stamps panel list

## **Non-Bureau MGA:**

'Code' – the UMR (up to 17 digits beginning with B) of the Binding Authority Agreement; the Binders agreement number; or any other appropriate agreement number or code for the capacity behind the MGA, such as a syndicate code, LIRMA number, consortium registration, etc

'Stamp Description' – full details of the binding authority agreement, the full details of the delegation, and the settlement terms

'Short Description' – text precisely identifying the stamp in the Stamps panel list

## **LIRMA**

'Code' – the 5-character LIRMA code of one capital letter and four digits

'Stamp Description' – the full organisation name and the text "LIRMA"

'Short Description' – text precisely identifying the stamp in the Stamps panel list

## **ILU**

'Code' – the 6- or 7-digit ILU number, which cannot begin with 0.

'Stamp Description' – the full organisation name and the text "ILU"

'Short Description' – text precisely identifying the stamp in the Stamps panel list

## **Non-Bureau**

'Code' – optionally, the DUNS (9 digits) or DUNS+ (9 digits + 4 characters) code of your organisation.

'Stamp Description' – the full regular details of your organisation

'Short Description' – text precisely identifying the stamp in the Stamps panel list
