Headlines

Brokers are able to add internal notes to a contract Contracts can now contain red text and inline images Brokers may duplicate a draft as a new draft version under the same contract.

Release Details

New Features

- Adding Internal Notes to a Contract
 - Brokers can add contract-specific notes using the new 'Internal Notes' tab.
 - The new tab is located to the top right of the screen, near the profile icon.
 - Internal notes are visible to team-members, but do not form part of the contract, and are not shareable with underwriters.
 - Additions and edits to internal notes are tracked in the broker's contract history tab.
- Mapping Custom Contract Headings to Standard MRC Headings
 - To maximise usability, the defined data tags available for tagging text are dependent upon the standard Lloyd's MRC contract heading that the text falls under.
 - It is now possible to associate a custom contract heading with a tag-bearing MRC contract heading.
 - This provides access to the tags held under the contract heading for the associated text.
 - Text must be completely untagged before re/selecting the associated MRC contract heading.
- Duplicating a Draft Contract as a New Draft
 - Draft contracts can be duplicated as new drafts by selecting the 'Duplicate Draft' action.
 - These new drafts are located within the same contract as the original.
 - Drafts are clearly numbered according to their order of creation.

Enhancements

- Changing Contract Text to Red
 - Contract text can now be coloured red on a word-by-word basis,
 - Edit the contract heading, select the text to colour, and click the black 'A' icon with the red underline.
- Adding Inline Images to a Contract
 - Images in a range of common formats can be added to contracts between headings.
 - Click on the blue triangle icon at the end of a contract heading and select 'Add Image Below'.
 - Once imported, inline images cannot be edited, but can be removed by selecting their 'Remove Heading' action.
 - Images must be less than 10MB in size.
- Digitized contracts are now automatically marked as templates, and must be cloned before showing.
- Brokers can now suggest stamps when binding notify parties to a declaration.
- The internal review system now allows mandatory review of bindable quotes.
- More direct data tags are available under the 'Limits of Liability' contract heading.

Resolved Issues

- Cloning a template as another template no longer causes issues if the UMR is tagged.
- An underwriter who is shown multiple sections of a contract as a member of different teams will now see all of the sections shared.
- Brokers' requests to quote are preserved exactly as received by underwriters in all instances.
- Endorsements from non-sectioned contracts can now be cloned correctly for use in sectioned contracts.
- MI reports correctly show team changes and bindable quote leaders.
- Mid-term participant change endorsements no longer incorrectly indicate the contract leader under certain uncommon circumstances.
- Brokers can now create a new off-platform stamp as part of the process of recording a line in a mid-term participant change endorsement.
- Draft mid-term participant changes now correctly export after populating participant changes.
- On the overview screen, all thumbnails and chevrons display correctly.
